The May Annual Meeting included remarks by Michael McGarry, CEO of PPG and AMP '05, President and Treasurer reports, and officer and governor elections for 2018-2019.

Bill Slivka ended his 5-year term as President this past year. Bill did a fabulous job building membership and club engagement and organizing quite a number of interesting events for our Members and community. We truly thank Bill for his service. For this new year, Tony Sciullo stepped up and was voted in as President. We also welcome three new officers in Doug and Ann Zalla and Tom Ruppel.
